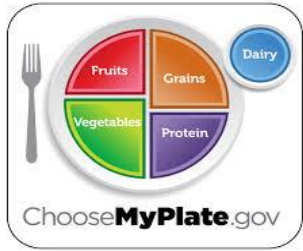





In addition to our daily entrée we also offer PB&J Crustable or Bagel w/Cream Cheese & String Cheese or Peanut Butter.
