

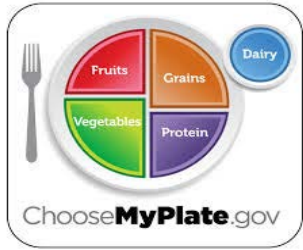



St. Mary's Lunch Menu
